

THE CORPORATION OF THE TOWNSHIP OF NORTH DUNDAS

BY-LAW NO. 09-2009

**BEING a by-law for fixing rates for the supply of water/sewer services.**

---

WHEREAS Section 391 of the Ontario Municipal Act, 2001, authorizes a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the *Ontario Municipal Act, 2001*, S.O.2001, c.25, s.81, authorizes a municipality to shut off the supply of a public utility if the fees or charges payable by the owners or occupants of the land are overdue;

AND WHEREAS the *Ontario Municipal Act, 2001*, S.O.2001, c.25, s.398(2), authorizes the collection of water and sewer rates in the same manner as municipal taxes;

NOW THEREFORE Council of the Corporation of the Township of North Dundas enacts as follows:

1. The rates, as set out in Schedules "A" through "C" attached hereto and forming part of this by-law, are hereby adopted and shall be in effect April 1, 2009.
2. Water/Sewer billings shall be issued quarterly with the exception of commercial large users, as determined by Municipal staff.
3. Commercial large users, as determined by Municipal staff, shall be billed monthly.
4. A surcharge of five percent shall be added to the bill if not paid on or before the due date.
5. All former by-laws or resolutions contrary to and inconsistent with all or any part of this By-Law (#09-2009) are hereby repealed including By-Law #13-2008.

READ A THIRD AND FINAL TIME AND PASSED IN OPEN COUNCIL THIS 24<sup>th</sup> DAY OF MARCH, 2009.

Village of Winchester  
Water/Sewer Rates

---

**WATER SERVICE RATES**

1. Water consumption in the Village of Winchester shall be measured by water meters.
2. The following fixed fee per year shall be charged for each meter depending on size:

Meter Size	Fixed Annual Fee
0.60 inches	\$75.00
0.75 inches	\$75.00
1.0 inches	\$106.00
1.5 inches	\$136.00
2.0 inches	\$219.00
2.5 inches	\$528.00
3.0 inches	\$830.00
4.0 inches	\$1056.11

3. In addition to the fixed fee, all accounts shall be charged \$0.67 per cubic meter for water.
4. In the event of a dispute between the water remote reading and the actual water meter reading, the reading on the actual water meter shall be deemed the correct reading.
5. Where multiple unit buildings do not have individual metering, *the landlord* shall be charged the current rates for water and sewer on the metered water volume.

**SEWER SERVICE RATES**

- a) Sewer fees shall be invoiced on the water bills at the rate of 148% of the water rate (including clauses 2 and 3 above) except as noted in section b) below.
- b) It has been established that Parmalat at 490 Gordon St. returns only 10,000 cubic meters to the sewer system per year. For this reason they shall be billed \$9,916.00 per year on the basis of \$826.33 per month in lieu of the regular charges in a) above.
