


PROVINCIAL OFFENCES ACT

BY-LAW NUMBER 40-2002

Being a By-law to Impose Fines

WHEREAS Section 320 of the Municipal Act, R.S.O. 1990, as amended, permits the Council of the municipality to pass a by-law for providing that any person who contravenes any by-law of the Council is guilty of an offence.

AND WHEREAS Council deems it desirable to have fines which meet the anticipated cost to the municipality of enforcing By-law 25-2001.

NOW THEREFORE the Council of the Township of North Dundas enacts as follows:

1. The list of imposed fines for certain offences contained in By-law 25-2001 are attached hereto as Schedule "A" of this By-law and does adequately reflect the cost of enforcing By-law 25-2001 for the Township of North Dundas.
2. The imposed fines shall become effective upon the approval of same by the Chief Justice of the Provincial Offences Court.
