Recycling Makes "Cents"

At current rates, the Boyne Road landfill is slated to be full in 2023. At that time, it is expected to cost North Dundas taxpayers \$1 million to close and cap the landfill. In addition to that major expense, it will cost another \$500,000 to monitor the site for the following 20 years. To prolong the landfill's life and save taxpayers money, Council has implemented a two bag residential

garbage limit and encourages everyone to reduce, reuse, and recycle! Details on recyclable items are available on our website or by contacting the landfill at 613-774-5157.

Recreation Facilities Enhance Quality of Life

Council is ensuring that we have quality recreation facilities that can be enjoyed by the next generation and beyond. In 2013, upgrades were made at the Chesterville Arena, Winchester Centennial Pool, Harmony Park and the Nelson Laprade Centre. Planned upgrades for 2014 include renovations at the Joel Steele Arena, Winchester Centennial Pool House, Mountain Memorial Park, and Chesterville Community Centre.



DID YOU KNOW?

- Your municipal tax dollars support local social services and social housing, including two seniors apartment facilities in Winchester (36 units) and Chesterville (25 units).
- Your county tax dollars operate 18 library branches across SD&G. North Dundas taxpayers contribute \$346,744 per year to operate the four North Dundas branches.
- When surface treating a gravel road, the largest expense is not the actual surface treatment but the preparation and building of the road base.
 Many roads need several inches of gravel, improved ditching and the installation of filter cloth before laying the tar-and-chip surface.
- In its first year, the Township of North Dundas Community Improvement Plan provided funding to 13 projects resulting in \$116,000 in improvements and renovations.
- \$264 million of new construction has taken place in North Dundas since amalgamation in 1998.
