By-Law No. 2020-16 of The Corporation of the Township of North Dundas to regulate the enclosure for privately-owned outdoor swimming pools and spas within the Township of North Dundas.

17.	Install a pool's pumping, filtration or heating equipment less than 3.5 m from an exterior yard lot line	11.1.2	80.00
18.	Install a pool's pumping, filtration or heating equipment in a front yard	11.1.3	80.00
19.	Install a pool's pumping filtration or equipment less than 1.2 m from the pool	11.1.4	80.00
20.	Install a pool's pumping, filtration or heating equipment that facilitates climbing	11.1.5	100.00
21.	Fail to enclose the equipment	11.2.1	80.00
22.	Install a pool or enclosure that alters the storm water drainage patterns	13.1	100.00
23.	Fail to comply with a notice	14.4	250.00
24.	Hinder or obstruct an Officer	15.4	350.00
25.	Attempt to hinder or obstruct an Officer	15.4	350.00
