

THE CORPORATION OF THE TOWNSHIP OF NORTH DUNDAS

BYLAW NO. 2025-71

Being a Bylaw for fixing rates for the supply of water/sewer services

WHEREAS Section 391 of the *Ontario Municipal Act, 2001*, authorizes a municipality to pass bylaws imposing fees or charge on persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the *Ontario Municipal Act, 2001*, S.O.2001, c.25, s.81, authorizes a municipality to shut off the supply of a public utility if the fees or charges payable by the owners or occupants of the land for the supply of the public utility are overdue;

AND WHEREAS the *Ontario Municipal Act, 2001*, S.O.2001, c.25, s.398(2), authorizes the collection of water and sewer rates in the same manner as municipal taxes.

NOW THEREFORE Council of the Corporation of the Township of North Dundas enacts as follows:

- 1.0** The rates, as set out in Schedules “A” through “B” attached hereto and forming part of this bylaw, are hereby adopted and shall be in effect January 1, 2026.
- 2.0** Water/Sewer billings shall be issued quarterly with the exception of commercial large users, as determined by Municipal staff.
- 3.0** Commercial large users, as determined by Municipal staff, shall be billed monthly.
- 4.0** A monthly surcharge of one and one quarter percent shall be added to the bill if not paid on or before the due date.
- 5.0** All former bylaws or resolutions contrary to and inconsistent with all or any part of this Bylaw (2025-71) as of December 31st 2025 are hereby repealed including Bylaw 2024-79.

Schedule “A” to Bylaw No. 2025-71

Village of Winchester and Chesterville Water/Sewer Rates

1.0 Water service rates

- 1.1 Water consumption in the Village of Winchester and Chesterville shall be measured by water meters.
- 1.2 The following fixed fee per year shall be charged for each meter depending on size:

Meter Size	Fixed Annual Water Fee
0.60 inches	\$166.56
0.75 inches	\$166.56
1.0 inches	\$233.28
1.5 inches	\$299.88
2.0 inches	\$483.12
3.0 inches	\$1,844.40
4.0 inches	\$2,347.44
6.0 inches	\$3,521.16

- 1.3 In addition to the fixed fee for water, all accounts shall be charged \$1.51 per cubic meter for water.
- 1.4 In the event of a dispute between the water remote reading and the actual water meter reading, the reading on the actual water meter shall be deemed the correct reading.
- 1.5 Where multiple unit buildings do not have individual metering, the landlord shall be charged the current rates for water and sewer on the metered water volume.

2.0 Sewer service rates

- 2.1 Sewage discharge in the Village of Winchester and Chesterville shall be based off the consumption measured by water meters.
- 2.2 The following fixed fee per year shall be charged for each meter depending on size for sewage:

Meter Size	Fixed Annual Sewer
0.60 inches	\$282.48
0.75 inches	\$282.48
1.0 inches	\$395.40
1.5 inches	\$508.44
2.0 inches	\$819.12
3.0 inches	\$3,126.96
4.0 inches	\$3,979.68
6.0 inches	\$5,969.52

- 2.3 In addition to the fixed fee for sewer, all accounts shall be charged \$2.75 per cubic meter of water consumed. These fees shall be invoiced on the water bills, with the only exception being section 2.4.
- 2.2 It has been established that Lactalis at 490 Gordon St. returns only 10,000 cubic meters to the sewer system per year. It has also been established that they have a 4.0 inch meter. Based on this amount they shall be billed \$27,500 per year for sewage and the fixed annual sewer charge of \$3,979 on the basis of \$2,623.25 per month in lieu of the regular charges in 2.3 above.
- 2.3 Properties that are only billed for sewer will be billed based on their private water use including the applicable fixed fee from section 2 above.

2. Miscellaneous sale of water to individuals or companies not connected to the water system	\$5.64 per cubic meter
3. Account Setup Charge	\$10.00
4. Collection Charge (24 hour shut off notice)	\$10.00
5. Disconnection Charge	\$65.00
6. Reconnection Charge	\$65.00
7. NSF (non-sufficient funds) Charge	\$25.00
8. Water/Sewer Customer Deposit	\$250.00
