This full-time position is currently vacant, and plays a key role in the year-round operation, maintenance, and care of Township-owned recreational buildings and public-use spaces. The successful candidate will take pride in providing safe, clean, and welcoming environments for residents and visitors while supporting a positive image of the Township.

The Facilities Operator is responsible for a wide range of hands-on tasks that vary with the seasons. In the winter months, the focus shifts to ice-making and indoor facility maintenance, while in the summer, attention turns to outdoor landscaping, ball diamond and sports field preparation.

This position requires strong knowledge of facility operations, preventative maintenance, and workplace safety practices. The ideal candidate is highly motivated, flexible, and capable of working both independently and as part of a team. They must possess excellent communication skills, attention to detail, and the ability to adapt to shifting priorities. Candidates should be comfortable working in varied indoor and outdoor conditions, handling physical tasks, and responding professionally to the public.

The position is based on a 40-hour work week and requires availability for days, evenings, weekends, and holidays, depending on seasonal and facility demands. Occasional extended or modified shifts may be required for emergency repairs or special events.

Position Summary

The Facilities Operator is responsible for the year-round operation, maintenance, and care of Township-owned parks, recreational buildings, and public-use spaces. This role involves a wide range of hands-on duties that vary by season, including ice making and indoor maintenance in winter, and outdoor landscaping and sports field preparation in summer. The Facilities Operator ensures that all spaces are safe, clean, and welcoming for the public while supporting a positive image of the Township.

Primary Responsibilities

- Perform daily facility and grounds inspections, prioritizing public and staff safety
- Operate and maintain equipment including ice resurfacers, landscaping tools, and pool systems
- Maintain, clean, and repair indoor and outdoor recreation spaces including arenas, community halls, sports fields, ball diamonds, playgrounds, outdoor rinks, and public pools
- Support community events through facility preparation and takedown
- Supervise and provide direction to part-time and seasonal staff
- Monitor and maintain building systems such as refrigeration plants, HVAC, plumbing, and electrical components
- Complete routine landscaping tasks such as mowing, trimming, and seasonal cleanups
- Maintain accurate maintenance logs and inspection reports as assigned
- Follow all health and safety requirements including WHMIS compliance and use of proper protective equipment
- Respond professionally to public inquiries and assist facility users as needed
- Conduct general facility repairs and address maintenance issues across municipal recreation sites
- Coordinate effectively with contractors, user groups, and volunteers to ensure facility use standards are met

Knowledge, Skills, and Attributes

- Working knowledge of recreation facility operations and preventative maintenance practices
- Experience in ice making, pool maintenance, and landscaping
- Familiarity with plumbing, electrical, HVAC, and general carpentry
- Ability to operate and service various machinery and equipment
- Strong understanding of workplace safety procedures and emergency response protocols

- Excellent communication skills, both verbal and written
- Ability to manage time effectively and adapt to shifting priorities
- Conflict resolution skills and ability to remain calm and professional in challenging situations
- Demonstrates initiative, attention to detail, and pride in workmanship
- Committed to teamwork, customer service, and community engagement
- Flexible and willing to adapt to varying schedules, duties, and work environments
- Motivated to assist other municipal departments when required

Working Conditions

- Work is both indoor and outdoor in varied weather conditions
- Regular exposure to chemicals, machinery, and equipment
- Some risk of physical hazard when working at heights or with tools
- Frequent walking, standing, lifting, and manual handling
- Will be climbing ladders, working on ice surfaces, and on pool deck areas
- Must be physically able to perform repetitive tasks, lift heavy objects, and work in confined or elevated spaces

Working Schedule

- This is a full-time position based on a 40-hour work week
- Work schedule includes days, evenings, weekends, and holidays depending on seasonal facility requirements
- Flexibility is required to accommodate special events, emergency repairs, and peak usage periods
- Occasional extended or modified shifts may be necessary

- First Aid, CPR, AED, and WHMIS certification
- Certified Ice Technician designation an asset
- Pool and Spa Operator certification an asset
